

APPRECIAITION

'A Pillar of Visakha Vidyalaya'



Savitri Nagodavithana

was a friend to all at Visakha Vidyalaya. Her services to Visakha span over half a century. She was a very active member of the OGA whose loyalty and sincerity were appreciated by all. Members turned up in their numbers to pay their last

respects to her - deeply shocked by the suddenness of Savi's demise.

Savitri joined Visakha Vidyalaya in 1951. She found school life fun and participated in many extra-curricular activities. She was Vice Captain of Dias House and a keen and active Girl Guide who later became a Warranted Guider and Sylvanna of 11th Colombo.

Leaving school in the mid 1960's, Savi joined the State Tyre Corporation as the one and only woman designer of Tyres at the time, and worked there for many years. Savi was involved with the OGA from the time she left school, participating in all the activities, often taking a key role in the organization. The 'Visakha Walk' from 1992, the annual 'Avurudu Pola' starting from the 1980s, 'Coffee Evening', 'Visakhians in Concert', 'Visakha Geetha Natakaya' and 'Pulimood Memorial Oration' are some of them. She served as an Executive Committee member on several occasions and held the post of Treasurer as well.

Savi appreciated history and valued the archives and the architecture of the original buildings in our school. She was involved in the renovation of the old hall and the Jeremias Dias Memorial hall projects, spending much time in school in between her office work to supervise the construction work. She was quick to detect any defects in the old hall and getting them speedily attended to.

She was the initiator of the Centenary Commemorative Coin, convincing a few senior members to meet with the Central Bank officials to get their approval, and pushing it through to reality.

As a result of this endeavor Visakha Vidyalaya became the only Girls' school in the Island to have a Centenary Commemorative coin.

Savi shunned publicity and did not seek prominence. She always maintained her stance 'Whatever we do, we do it for our school, not for individuals - and it is a team effort.' She acted quietly making sure that everything went smoothly. An anxious observation 'We forgot something' would bring forth a reply with a smile - 'It has been done.'

We called Savi 'A Pillar of Visakha Vidyalaya'. Her loyalty to the school was indisputable. Travelling from Maharagama by public transport, her lack of concern for her own comfort and safety were characteristic of her selfless service. Even though she suffered from arthritis in later years, it did not deter her from her commitments. Rain or shine Savi would participate.

Savitri was a very independent person. She was not after popularity or personal gain, and stood up fearlessly against the establishment if she felt a wrong was being perpetrated. We miss her indignant outbursts against injustice, unethical practices and lack of transparency.

She was key player in the compilation of the Visakha Centenary Publication. Her contribution to this venture from the beginning is deeply appreciated and we are sad she could not see the completion of the book. The VVOGA Exco decision to appreciate the Centenary Celebrations Committee at the 2018 AGM was timely. Savi accepted her token of appreciation, and the very next day entered hospital never to return. She is sadly missed by all those who knew her and worked closely with her over the last 50 years. She was always there to share her experience and support any cause - big or small. In her demise the VVOGA lost a caring, loyal member whose long dedicated service to our alma mater cannot be measured.

May her Samsaric journey be short and may she attain the supreme bliss of Nibbana.
